Terms and Conditions of End-User License Agreement

The software upgrade program for Denon DN-SC3900 model provided herewith (the "Software") is proprietary to DENON DJ, a division of inMusic Brands. ("DENON DJ") and has been made available to you only in accordance with and subject to the terms and conditions of this License Agreement. By installing or using the Software, you will be confirming your acceptance of the Software and your agreement to be bound by all of the following terms and conditions, including, without limitation, the disclaimers which are a part hereof: IF YOU DO NOT AGREE TO THE FOLLOWING TERMS AND CONDITIONS DO NOT INSTALL OR USE THE SOFTWARE.

1. **Title.**

The Software is the property of DENON DJ. No title or ownership therein or thereto is transferred to you hereunder. This License only provides you with certain prescribed rights to use the Software, subject always to the terms and conditions herein set forth. All rights in and to the Software are reserved by DENON DJ.

2. **Limited Rights of Use.**

This License only allows you to use the Software for your own internal purposes and solely in connection with a Denon DN-SC3900 player that you personally own (the "Product"). The Software is licensed not sold. All rights not specifically granted to you hereunder are retained exclusively by DENON DJ.

3. **Non-Disclosure.**

You acknowledge that the Software is proprietary to and a trade secret of DENON DJ, and you agree not to make or distribute copies of the Software or to transfer the Software electronically or otherwise to any other person. Uploading the DN-SC3900 System Software

1. Unzip the update file that you downloaded from **denondj.com** to a folder of your choice. Example: ("My Documents" or "Desktop")
2. Using your computer, find the unzipped file **SC3900FW.BIN** and copy it to the root of a USB memory device. (Flash Drive, Hard Drive...etc) **The drive must be formatted as FAT/FAT32!** When file copy is complete, safely remove the USB memory device from your computer.
3. Make sure the power of the DN-SC3900 is currently turned **OFF**.
4. Insert the memory device (Flash Drive Hard Drive...etc) into the **USB-A** port on the top panel of the DN-SC3900.
5. On the DN-SC3900, press and hold the **BACK: left & right arrow buttons** (see Fig 1 below).

While holding both back arrow buttons **Power ON** the DN-SC3900. Once the display says, **VerUP Mode, Push Cue** you can release these two buttons.

6. Press the **[CUE]** button. You will see **Current Version -> Update Version, Push Play.**
7. Push the **[PLAY/PAUSE]** button, then display will first indicate: **Now Updating, Keep Pow ON**

****It takes about 60 seconds to complete the entire update, please wait.***



Keep the power ON. Never shut the power off during actual execution of version update. If you shut the power off during this period, the DN-SC3900 will require service.

8. When the player is finished updating the screen will show, **Complete!, Please PowOFF.**
9. It is now OK to turn the power OFF and reset the player back to normal mode.



SC3900 PLUG IN'S SOFTWARE IMPROVEMENTS

New & Current Firmware as of November 2014 (Sys 1168)

- Now Supports 500 Playlists & Crates from previous 99 limit
- Improved the RPM setting in UTIL mode as change is affected immediately
- Improved the output level for Serato in Hybrid MIDI mode to avoid clipping
- Fixed a problem that when unit is in MIDI mode, the track can be loaded via engine for iPad
- Fixed the problem that sometimes wrong title is appeared
- Fixed the problem that sometimes Track Prev./Next buttons do not work
- Fixed the problem that when Brake function is available, the playback doesn't stop despite pause status
- Fixed the problem that sometimes slave unit is muted after additional unit is connected to same network

Previous Improvements included with this build

- Fixed, playlist/crate names disappear when there are more than 64 crates/playlists in the media list.
- Fixed, CD-ROM file/folder names disappear when there are more than 64 files and folders in the same directory of the CD-ROM.
- Fixed, when the connected media has more than 256 crates, sometimes selected crate and loaded crate are different.
- Fixed, when Crates had similar naming structures, files would show in more crates than they should.
- Fixed, when two units are linked together and one has a USB flash drive connected, the "slave" unit will freeze and not load files by Title search
- Fixed a problem that incorrect track information is sometimes displayed when move to a different track by using Hot Start function
- Improved media access speed
- Resolved an issue where BPM display sometimes disappears when a file is reloaded
- Improved CD-ROM search function when players are connected by 'LINK' mode
- Improved particular MP3 files that didn't play properly
- Improved the function of first letter search when using database search
- Improved problem that the sound becomes silent when playing network audio file
- Improved problem that the cue point is moved after a particular operation
- Added the function of Hotlist when connecting to engine Ver1.1.0.
- Added the function of Folder search when connecting to engine Ver1.1.0.
- Improved the cursor navigation function of engine when operated by the player (The cursor now moves with no limit at engine tree window when turning "SELECT" knob.)
- Added "EXIT ENGINE" and "CANCEL" menu option when "LINK" button is pushed. (previously you could not exit engine from the player)
- Added the function to support Mono audio files (MP3/AAC/WAV/AIFF)
- Improved platter pitch rotation offset speed relative to the pitch slider position, which avoids subtle pitch drift during Vinyl mode. (prior firmware versions had subtle pitch drift)

- Improved the database function of BPM data when the memo BPM data is changed. (previously mismatched between engine and ID3 Tag)

- Improved the “History” function (previously had the problem that played songs sometimes are not added to History)
- Improved scratch sound in conjunction when KeyADJ. is turned on
- Improved the function of continuous play when used in conjunction with engine (previously, only Single mode was available)
- Improved the problem of “Can’t Open” file when using network LINK or 2 player LINK
- Increased the value of shown folders and files when using folder search.(Max Folder:2048 File:1024 per folder) Previously was, Folder:1024, File: 512 per folder.
- Improved AAC file playback that now supports up to 80min in length. Previously AAC files over 60min displayed, “Can’t Open” error.
- Improved the malfunction of Hybrid MIDI mode if USB connection was disturbed or purposely disconnected. (in v1050)
- Improved Hybrid MIDI mode when setting a Temp Cue for Serato Scratch Live in “Standard” Cue mode. (previously the desired point shifted when set)
- Improved the MIDI platter data format in Normal MIDI mode to be the same as DN-S3700.
- Improved other minor bugs
- Improved – Vinyl backspin action to prevent rare audio stutter or pause around beginning of file
- Improved – Scrolling Title Error with Engine files
- Improved – Letter database search function when using Engine iPad version
- Improved – Key adjust from turning off after loading Engine files
- Improved – Button LED feedback when using Traktor2 in MIDI modes
- Add new function, “BPM Sync OFF”
 - When “BPM Sync” and “Shift” buttons are pushed on Master deck, BPM Sync turns OFF
- Improved – ‘Can’t Open’ file error from the Slave unit in LINK mode
- Improved – Memo file Loading function
- Improved – Pitch Drift when Vinyl mode is ON
- Improved – Network Memo & Audio file open function during Link mode.
- Improved – System freeze in USB mode when certain external HDD’s would enter sleep mode
